# SSG 401(K) PLAN BASICS

## 401(k) Plan Overview

- \* Two types
  - Traditional (pre-tax contributions)
  - Roth (after-tax contributions)
- \* Depends on <u>when</u> you want to pay taxes
  - Traditional = at retirement (deferred)
  - Roth = now (and not at retirement)
- \* Your choices
  - Traditional, Roth, or both

# SSG 401(K) PLAN BASICS

## How Our 401(k) Works

- \* Save up to 100% of your compensation
  - \$18,000 annual limit
  - \$24,000 annual limit (age 50+)
- \* Company match
  - Dollar-for-dollar up to first 3% you contribute
  - 50-cents-on-dollar for up to next 2%
    - Example: If you contribute 5%, company match = 4%
  - Matches are immediately vested (i.e., it's your money)

#### \* Withdrawals

- No loan provision
- No withdrawals before 59 ½ without taxes and penalties\*
- Rollovers
  - You can rollover savings from previous retirement plans into this plan




